



RACER'S AGREEMENT 2005

PURPOSE:

This Racer's Agreement sets for the requirements for Tripower (TP) racers in order to be eligible for team benefits including sponsorship offers, discounts and race fee reimbursement.

RACING REQUIREMENTS:

- a) Racers shall compete in 12 races before October 31, 2005.
- b) Racers shall compete in 5 of the 12 races by July 17, 2005.
- c) Racers over age 30 shall race in 3 of the 5 VA state championship races. Racers under 30 shall race in 2 of the 3 VA state championship races.
- d) 8 of the 12 races must be USCF Virginia BAR races (calendar at VaCycling.org).
- e) 4 of the 12 races may be any combination of USCF sanctioned races (including training races; mountain biking events, etc.). Only 2 training races shall count towards the total.
- f) Races other than USCF sanctioned events are not eligible (e.g. triathlons, duathlons, competitive tours, etc). However, these events shall be listed on the race data sheet described below.
- g) Racers shall maintain a race data sheet provided by TP listing all race competition.
- h) Race data sheets shall be delivered to race captains on July 17 and October 31.
- i) No more than 2 DNFs shall count towards race total.
- j) TP jerseys must be worn in all race events.
- k) 2 races from one event count as 2 races.
- l) Racers must maintain good sportsmanship with teammates and opponents.

VOLUNTEER REQUIREMENTS:

- a) Racers shall volunteer to work in at least one of the following by July 17, 2005:
 - i. Conte's Cycling Classic planning and preparation
 - ii. Amphibious Assault Criterium planning and preparation
 - iii. Other TBD event planning and preparation
- b) Racers shall volunteer to work in at least one of the following by July 17, 2005:
 - i. Conte's Cycling Classic race day
 - ii. Amphibious Assault Criterium race day
 - iii. Other TBD event race day
- c) Racers shall log volunteer time on race data sheet.

GENERAL REQUIREMENTS:

- a) TP jerseys shall be worn at all local group training rides.
- b) BAR/Omnium Champions shall wear championship jersey with TP shorts.
- c) Racers shall abide by traffic laws.
- d) Racers shall follow ride leader's rules.

RACER BENEFITS:

Discount Merchandise:

- a) Eligible Racers under this agreement shall qualify for merchandise discounts.
- b) Racers shall abide by all guidelines for ordering and purchasing merchandise.
- c) Racers shall not discuss discounts with anyone except teammates.
- d) Racer discount shall apply only to merchandise purchased for personal use.
- e) Racers shall not purchase discount merchandise for anyone else.
- f) Racers who did not comply with the requirements of the 2004 TP Race Agreement shall not be eligible for discount merchandise after July 17, 2005.

Racer Fee Reimbursements:

- a) TP will endeavor to reimburse eligible racers to the extent possible.
- b) Racers shall maintain accurate race data sheet information to be eligible.
- c) Racers shall maintain accurate volunteer information to be eligible.
- d) Late fees are not subject to reimbursement.
- e) Reimbursement of the 12 mandatory races takes priority over additional events.
- f) Racers shall be in good standing throughout the entire season to be eligible.
- g) TP officers and race captains shall determine reimbursement eligibility and amounts.

PENALTIES:

- a) Racers who do not participate in at least 5 races by July 17, 2005 shall lose eligibility for discounts and reimbursements.
- b) Racers who do not participate in at least 12 races by October 31, 2005 shall not be eligible for 2006 discounts and reimbursements.
- c) Racers who do not complete volunteer requirements by July 17 shall lose eligibility for discounts and reimbursements, and shall not be eligible for 2006 discounts and reimbursements.
- d) Racers violating any other portion of this agreement shall lose eligibility for 2005 discounts and reimbursements, and shall not be eligible for 2006 discounts and reimbursements.
- e) Enforcement of penalties shall be determined by TP officers and race captains by unanimous decision.

- Conte's Cycling Classic planning and preparation _____
- Amphibious Assault Criterium planning and preparation _____
- Other TBD event planning and preparation _____

b) Select at least one of the following for volunteer requirement:

- Conte's Cycling Classic Race Day _____
- Amphibious Assault Criterium Race Day _____
- Other TBD event race day _____
